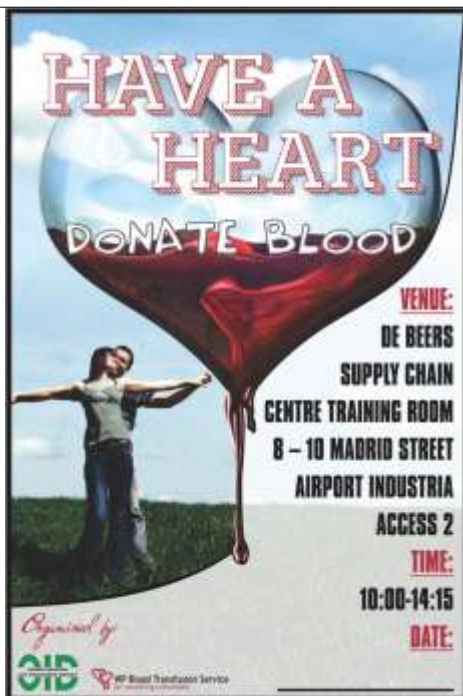

Blood Donor Clinic

Airport Industria City Improvement District decided as part of our Social responsibility toward the community arrange with the Western Cape Blood Transfusion Service to deliver a service to all our workers in Airport.

De Beers, situated in Madrid Street, Airport Industria 2 very kindly offered their premises for this blood donation project, the details are as follows:

They are able to “bleed ” four people at a time. The donation process takes approximately 20 minutes. Completing the form takes up most of the time. The donation itself takes about 10 minutes. Forms have been delivered to the CID office, which the donors can complete on the morning of the donation, before arriving at the clinic. This will reduce the amount of time away from work. Please feel free to contact Rhonda Lewis at the CID office, who will arrange to have the forms delivered to your company. Please advise on the number of employees who will donate blood, to divide the companies into groups and prevent too many people attending at once and keeping workers away from work for too long.

DUMPING

Illegal dumping and sewer blockages is when residents or businesses dispose of their waste in an improper way, causing environmental damage and harm to the community. Eg. Dumping waste in open fields, along roads, down sewer systems.

It is shocking to see the amount of illegal dumping on a daily basis in Airport Industria, and the complete disregard for the law as well as health of the public and environment. The waste and building rubble is not just dumped by people from outside the boundary of Airport Industria but dumped by businesses in our area.

The CID takes photos of illegal dumpers and refer this to Law Enforcement to take the appropriate action. Fines of up to R10 000.00 can be issued for illegal dumping by Law Enforcement.

We ask business to help the CID to be proactive in this regard and report illegal dumping to the CID office on 021 386 8403, CID Security on 0271416403 or contact The City on 021 400 6157 or send an email to solidwaste.bylaw@capetown.gov.za. If dumping is noted, please take the registration details and pass this onto the CID Manager to investigate.

Give your Contact Telephone Number clearly

Give your Exact Location - name of company, street name,

Take the name of the person to whom you are reporting the incident and time you reported the incident
