The City announces date

The City will conduct a general valuation of all properties from 1 July 2012 as approved by Council. In accordance with the mass appraisal principles used by the City, the size, sales figures and physical attributes of properties will be taken into account when determining the rateable value of a property.

The final valuation role will be certified by the Municipal Valuer and submitted to the City Manager on 31 January 2013 and the role will be open for inspection and the

lodging of objections during March and April 2013.

Notices will be posted to property owners in February 2013 to advise them of their GV2012 valuation, and of the procedure to lodge an objection if they disagree with the valuation.

The GV2012 values will be available on the City of Cape Town's website as from end February 2013.

What is a CID

A City Improvement District (CID) also known as a Special Ratings Area (SRA) is a non-profit organisation operating within a defined geographic area within which property owners agree to pay a levy for supplementary and complimentary services set to enhance the physical and social environment of the area.

A CID, according to the SRA by-law collects a CID levy from the ratepayers in the area over and above the normal rates charges. The money collected, unlike the rates, is a dedicated levy which **can only be spent in the specific CID area and is used to provide "top up" services according to an** approved Business Plan. These services provided by the CID are supplementary to those provided by the City of Cape Town, which continues to provide normal services.

The advantages of establishing a CID

- · The cost of providing supplementary services will be borne by all property owners
- · Costs are borne in proportion to the value of the property
- · The Improvement District approach is holistic
- · Provides enhancement of the environment and strengthens investor confidence

Fence Repairs

The fence along Montreal Drive and N2, presents endless problems as it is continuously cut by vagrants and workers in Airport Industria to gain easy access into and out of the area. The CID had various discussions with Provincial Authorities to assist with this

challenging nightmare. Provincial Authorities agreed and erected 200m of new fence.



Area Cleaning

The CID continuously cleans every street within Airport CID. We have 6 dedicated street sweepers sweeping the streets, keeping water canals clear from sand and picking up of litter. From the beginning of the year the cleaning team have used 1287 bags which mostly consist of litter along the road side. This is an indication that we face a massive challenge here!



The street sweepers are all hard workers and currently face cold inclement weather. Some businesses have asked if they could offer the workers soup or coffee? The CID will appreciate your kindness.

Dumping is illegal

We appeal to everyone in Airport Industria to call the 24 hour CID security vehicle when spotting a suspicious vehicle or people that may be dumping building material, garden refuse, old tyres or broken pallets as this is a serious problem on a daily basis.

The sad part is that businesses within our area dump their company waste in our streets, and when confronted they deny the dumping!

What is being done about littering and dumping?

The new <u>Bylaw</u> sets fines between R500 and R10 000. It also calls for criminal sentences of 6 months to 2 years for certain offenders. In serious cases both fines and prison sentences can be handed down

The new Bylaw also broadens the responsibility of ensuring that contractors dispose of waste lawfully

The City seeks a collaborative approach to solving this problem. Cleaning up litter and illegal dumping are the two biggest waste removal costs, all of which are paid for by the ratepayers.

Crime a Never Ending Saga

Owing to high levels of unemployment, crime is on the increase daily, which unfortunately affects us in Airport Industria. Hand-bag snatching, mobile phones being taken from workers walking to and from work or from people sitting in motor vehicles waiting for relatives/friends or to conduct business, etc. They are unfortunately confronted at gun point or with a knife, and due to fear they do not report these incidents to CID or SAPS, therefore the offenders get away!

The majority of crimes occurring in our areas are non-violent crimes. These are generally grouped under "transgression" of the by-laws which apply to the following: being drunk and disorderly; urinating in public; malicious damage to property; failure to comply with an instruction from a law enforcement official, littering; loitering and so forth.

Committed to seeing these crimes abolished, the CID, in conjunction with the applicable law enforcement officials, have adopted a **'pro-active'** policing approach. This type of policing has proven to be very successful. However <u>public participation</u> <u>is key</u>. We therefore urge the public to bring the actions of individuals who transgress the by-laws to the attention of the CID Manager and CID Security and/or SAPS officials as this enables us to address these incidents and thus collectively reduce crime.

All break ins must please be reported to the CID office or CID 24 hour security. This will help us to keep track of crime statistics and help us identify the patterns of the crimes committed.

We have implemented a quarterly verge/garden competition whereby frontages and gardens of companies will be monitored and evaluated


A floating plaque is given to the winning company, which is placed in the reception area until the next quarter. A wine hamper is also given to the person managing the verge and garden
