5.1) Approval of minutes

5.2) Matters arising from the 2021 AGM minutes.

6) Chairman's Report

Anthony Healey gave feedback on the years' operations through a slide show and reported that the Directors identified the need for cameras in the Airport Industria area. All the entrances will be fitted with cameras and are currently being installed. The camera project is funded by the CID. Additional Funds are required to roll the project out to other streets. This will be discussed by our Treasurer Mr. Mc Murray

7) Feedback on Operations 2021/2022.

7.1) The CID funds cleaning Services.

Selton Cleaning Services have eight workers.

They cut the grass on the verges

The waste is bagged and the bags collected by CCT (Parow)

7.2) Defects list

The manager generally makes a weekly list of defects and forwards it to CCT. The list is accompanied by photographs and addresses.

The most frequent subject is potholes and road deterioration.

Law enforcement issues are also addressed.

The CID will fund the 2022 road markings.

9) Special Resolution: Amendment of the new Memorandum of Incorporation

There is a delay in the approval of the CID By-law and Policy which has a direct impact on the approval of the new MOI. It was therefore agreed at the CID Forum meeting of 27 September that the MOI be withdrawn from the 2022 round of AGMs and postponed to next year to protect the CIDs and City's credibility

10) Noting of Audited Financial Statements 2021 /22

Neil McMurray went through the statements displayed on the slides and explained that about 90% of the budget was for security and cleaning.

He explained that CCT held back 3% for bad debts.

The Audited Financial Statements were approved.

Niel Rossouw indicated that crime is on the increase on a daily basis and this is due to the high unemployment.

Cameras are currently being installed at the three entrances being Bahraine, Michigan and Montreal Streets. Final installations are currently being completed, tested and pulled into the monitoring network.

He displayed camera footage of the Pan Tilt, Static and License plate Recognition cameras. On completion, the Smart Surveillance Cameras will be monitored in order to respond before intrusion occurs.
